## SAWAMISH COUNTY, WASHINGTON

Oregon has 36 counties. Washington, with less area but more population, has 39 counties. Idaho, with more area but less population, has 44 counties. Montana, the largest state in our area of the four, has 56 counties. This makes a total of 175 counties in the states covered by *The Oregon Country* (journal of Pacific Northwest Postal History Society).

But there are a few counties missing, entities that existed briefly but are no more. Oregon had an Umpqua County on the lower Umpqua River, with the county seat at Scottsburg. Its area was mostly absorbed by Douglas County. Idaho had two large counties that encompassed much of southern Idaho north of the Snake River, Alturas and Logan Counties. When irrigation was introduced, the population increased and the numerous small counties of south-central Idaho were established, and Alturas and Logan ceased to exist.

Washington also has some missing counties. Ferguson County was east of the Cascades, covering much of what is now Kittitas and Yakima counties. The map on Page 4 shows the missing county of Sawamish.

This 1865 map has several items of interest. Little Wahkiacum (Waukiakum on the map) County, all 269 square miles, had already been carved out on the lower Columbia River. Clark County is spelled Clarke. A large Chehalis County is shown, before Pacific County was created and before it changed its name to Grays Harbor County.

An oddly-shaped Thurston County covered the area about Olympia; and to the northwest of Thurston County the map proclaims the existence of Sawamish County. It extends all the way to the Pacific Ocean, covering a large area with very little population. It was created by the Washington Territorial Legislature on April 15, 1854, and named after the local Indians.

Four post offices operated in Sawamish County, Arkada (1858-74), Kamilche (1862-68), Skokomish (1858-90) and Oakland (1858-69). Skokomish changed its name to Union City in 1890 and then Union in 1895, and is still operating.

Lunar New Year of the Snake

The only postmarks known from Sawamish County are manuscript markings from Oakland.

Sawamish County elected commissioners but had no permanent county seat. Meetings were held in the homes of the various officers. Most of them lived in the vicinity of Oakland, so even though there was no Court House, Oakland was considered the county seat. When they did select a site

# **Executive Secretary's Notes**



Philately moves on. Maybe it is time for reflection.

I remember going to shows in the 80s, especially PIPEX at many venues. Trying to build an exhibit from my collections (that is looking for new

and significant material), I lamented my access to new material which was via mail-order dealers, PIPEX and local shows of which we had many. Exhibitors in other parts of the US had an advantage over me. I had just two big shows with lots of material for sale within 500 miles of Southern Oregon, except when I didn't -- when PIPEX wasn't in Oregon. Most of them had twice as many big shows to attend.

I remember one Midwestern dealer at PIPEX in Spokane lamenting few sales. He had material I wanted at high prices. On Sunday we talked. He said that it was clear that prices were lower in the Northwest, and he dropped his a little so that I could buy about six covers.

Now, there are still only two big shows within 500 miles -- and few local shows or bourses. But what has changed is that now I can buy new and significant material via the internet from sellers on six continents at prices often set by auction. There is absurdly priced material, yes, but I ignore it. I am equal now with exhibitors in other parts of the US. This positive change for me as a collector has resulted in many fewer local shows, fewer dealers and for me anyway fewer transactions with mail-order dealers.

I remember my first exhibits. They were weak efforts, weak in material and in completeness. I remember the exhibits at the AMERIPEX International in Chicago in 1986. Looking at exhibits in areas I collected, I knew more about the material than the exhibitors there did; well, actually, I knew more than what the exhibitors put on the page. What has changed are the judging guidelines which emphasize explaining the material and telling a story with it. Knowledge and explanation are now more important than \$ value.

I remember club meetings. There were more of us then and, seemingly, more volunteers for the little jobs of keeping the club and our local show running smoothly. I remember the programs. There were auctions, at the most two a year. There were presentations by club members. There were slide shows from APS with that obnoxious ping or thunk to change the slide.

Now, there are more auctions which includes material donated to the club by non-collectors who have collections from deceased family members. There are still show-and-tell presentations, but they are less frequent, maybe because we are more specialized and less curious about other collections. However, the member presentations are often more polished because they are electronically produced.

What does this indicate about the future of philately in the Northwest, and what does it suggest we do?

About shows, it suggests that PIPEX is still important. It suggests that a few local shows become regional events with exhibits entered from throughout the Federation. It suggests that other "shows" be one-day events which require less organization and time.

About material, it suggests we are in a good place, except for the loss of collectors. This lack of collectors we need to address. We need to share, to explain and to promote our collecting bug. Mainstream philately has widened to include picture postcards, poster stamps and historical paper. Fun collecting and free-style exhibiting are on the rise and they need to be encouraged.

About club meetings, it suggests we use technology to widen who can view the presentations. This can be accomplished with Zoom presentations. The dissemination of a list of programs and of presenters to all Federation clubs should be done at the Federation level. We need a volunteer for this.

The current situation about club meetings and material also suggests that club auctions would have more benefit for each club and for philately if they could accept bidders beyond the local club members. This is an idea. The internet could be used for this. A <u>Clubs' Auction Coordinator</u> for the Federation would need to be found. If this suggestion intrigues anyone in the Federation, contact me or any other Federation volunteer listed on page 2 of this journal.

I hope many of you will come to PIPEX in Portland, May 2-4, 2025, and some of you will come to the Federation meetings or presentations. Philately remains important to us and to others. And above all, share your thoughts with us in letters to the editor. You influence the future direction of philately.

for the Court House, they found that parcel of land was already allocated to schools.

One of the commissioners was a teetotaller, so no liquor could be sold in Oakland. An enterprising businessman set up a bar on a boat at the site of Shelton, and soon Shelton emerged as the largest town. When the county boundaries were redrawn, Shelton became the county seat of Mason County, and Sawamish County disappeared. The western part of Sawamish County was included in Grays Harbor County. Curiously, the book *The American* Counties, compiled by Nathan Joseph Kane, says that Mason County was established March 1, 1854, yet Mason County does not appear on the 1865 map. Kane treated the transition from Sawamish County to Mason County as a simple name change. The HistoryLink website also says it is a name change, effected by the Legislature in 1864. Yet on the 1865 map, it is Sawamish County, not Mason.

### **MEET THE SPEAKERS 2025**

Note: Biographies are provided by the speakers.

Joe Voice – Pasco, WA: I have been collecting and researching stamps since about 1996. I started collecting to relieve stresses caused at the day job, working with a stamp dealer at a brick-and-mortar shop in Kennewick that knew how to get a potential collector hooked. That dealer allowed me to take recently acquired collections home to pick through charging just 10 cents for each stamp. Through looking at stamps and catalogs into early morning hours, I got to know a lot about worldwide stamps, narrowing my interests at that time to Greenland, Iceland and Bicycle stamps. I have continued adding to my collection of Greenland postal history. Other current collecting interests include AMG Germany, covers from the 2-cent US Airmail rate period, CAM-5/CAM-32 and the Varney Airgram. Now I enjoy research much more than collecting, leading into philatelic exhibiting starting in 2021. I've written technical articles that have been published in the journal of the Allied Military Government Collectors Club, resulting from research conducted for my US Navy patrol aircraft exhibit that correct and expand upon previously published information that is being incorporated into the latest revision of the Trans-Oceanic Record Flights section of the American Air Mail Catalogue currently in preparation by the American Air Mail Society. I also have a three-frame exhibit on the Varney Airgram that includes a design type catalog developed through my research for the Willamette Valley Exhibition and PIPEX; it also won a Gold Medal and the Marcus White Award for the best postal stationary exhibit at SEAPEX.


Raymond Villeneuve – Calgary, AB: Attending CAPEX 1987 with my youngest son got me started in philately. As an elementary school teacher, I soon found that stamps could be a useful tool with my students. I ran a school stamp club for about 10 years and organized youth club activities in local stamp clubs. Personal collecting interests started with thematics: OLYMPICS - stamps, covers, postmarks and poster stamps from pre-1956 countries where Olympic Games were held; UNESCO and its worldwide mission; Japanese New Year stamps and card traditions. I also got involved in postal history, first with my home county of Russell in Eastern Ontario and then with various auxiliary cancels and postmarks. For almost 15 years, I have been collecting Canadian Special Delivery covers and studying its service along with its forms, labels and postmarks. I have exhibited on Canada and U.S. Special Delivery service as well. Member and officer of stamp clubs in Ottawa, Calgary, BNAPS and a contributor to BNA Topics, Maple Leaf Journal, PHSC Journal and the Calgary Philatelist. Served on the organizing committees for OROPEX and BNAPEX.

**J W Palmer – Spokane, WA:** I have been collecting for 60 years and have never stopped. Started collecting when I was a child with my Aunt who came over every weekend on Sunday and we worked for 3 or 4 hours mounting stamps. My collecting was in US, Canada and United Nations in singles and plate blocks. In 1984 had a break in and lost my first volumes of US and Canada so decided I needed something new to collect. I bought a lot of proprietary and documentary battleships to try something new. Well it turned into a now lifelong collecting specialty of "The War Act of 1898" and everything concerning it. I also collect many other countries and have documents from all the tax periods. Have a few topical areas that have grown over the years. I have been involved in various positions from 1989 to 2011 for PIPEX and our local shows in Spokane. Volunteered at AIRPEX in Mesa for 10 years mounting exhibits and so forth. Have won a Grand and two Reserve Grands. Have been a board member of the Inland Empire Philatelic Society for 34 years and the President for over 20 years. Member of ARA, APS, AAPE, BCPSG, IEPS.

Steve Stiff – Missoula, MT: My interest in stamp collecting began in 1960 at the tender age of 7, when my cousin introduced me to the 7¢ red and the 7¢ blue US airmail stamps. Her father worked a plastics manufacturing firm and he shared a wide variety of US and foreign stamps from the mail he received. Needless to say, I was hooked, but life intervened. After many years, and a few fits and spurts, my granddaughter Izzy instigated my return to philately (with a nod to Mike Zak, her substitute teacher). Izzy excitedly showed me stamps Mike had awarded her for participation in class, and she told me about a stamp club in Missoula. That was seven years ago...My stamp collecting is currently focused on pre-1940 issues from the US, Great Britain, France and Canada. I also have an interest in early Hungary, Czechoslovakia and other European countries. I became interested in the Universal Postal Union when I purchased an album page with ten 1894 regular issue stamps; I wanted the damaged \$2 James Madison as a filler for my collection. Upon receiving the stamps, I discovered that what I thought were cancellations turned out to be overprints: UNIVERSAL POSTAL CONGRESS. Serious research directed me to the Specimen Stamps section of the Scott Specialized Catalogue of US Stamps and Covers. Further research showed that these stamps are part of a package of postal items gifted to the attendees of the 1897 Washington, DC, Universal Postal Congress of the UPU. That discovery prompted me to explore the 1897 UPU Congress and, by extension, the Universal Postal Union (UPU) and why it was created. And, of course, the international postal items issued to commemorate the UPU.

With the exception of a short period of inactivity during WWII, the organization has served as a common cause meeting ground for organized philatelic interests within these states and provinces. The Federation supports PIPEX (Pacific International Philatelic Exposition), an annual APS World Series of Philately (WSP) show, and the John D. Arn Symposium.

The Federation is the only organization of its type with cross border membership and WSP exhibition sponsorship. It continues its member organization communications with The Federated Philatelist newsletter. The annual Federation meeting takes place at the club hosted site of the annual PIPEX show.

# Alaska's Postally Served Locations Without a Local Post Office

The cover pictured in this article with a return address of Waterfall, Alaska, and a Ketchikan 1941 cancel is an example of one of Alaska's many partially postally served locations that did not or doesn't have a local post office. Some such locations were served for many years while others were very short-lived. These covers differ from those carried by express companies or by helpful private individuals such as those who brought letters to Dyea, Alaska, to be stamped and mailed from prospectors and others before interior post offices were opened by the U.S. and Canada during the Klondike Gold Rush. The Alaska Railroad also similarly served (serves?) some locations without post offices.

Covers like the one from Waterfall are different because the successful bidders for U.S. Alaska mail carrier contracts were sometimes required to provide pick-up and delivery services at qualified locations along the route that did not have their own post office. The exact arrangements had to be worked out to the satisfaction of the nearest postmaster and the residents of the location to be so served and at no additional cost to the government.

Waterfall, which is now a popular sport fishing resort, in 1941 was a cannery site served by Alaska Route #78073 (or an associated route) that served Ketchikan to Wrangell and Ketchikan to Hydaburg. Section 33 of the July 13, 1937, Advertisement Inviting Proposals for Carrying the Mails of the United Sates on Steamboat or Other Power-Boat Routes and the Star Routes in the Territory of Alaska for the period from July 1, 1938, through June 30, 1942, required the successful carrier to "...deliver mail into all boxes and hang small bags or satchels containing mail on

cranes or posts that may be erected along the route, and to collect mail from boxes or satchels..." with the items to be deposited at the next post office. U.S. stamps had to be applied before the mail was picked up.

There were many similarly served locations in Alaska during the 1938-42 period. The following is a partial listing of locations served, a close-by post office and the route that served the site.

The list also features still to be announced stamps recognizing cultural icons and other topics from these anticipated annual stamp series:


- A fundraising stamp for the Canada Post Community Foundation, supporting children and youth across Canada.


Hanukkah with Peacock emblem in back

parcels. I was finally able to ship a package to Canada on January 6, 2025; it was delivered to the Ontario home on January 23. I was able to order my booklets (which arrived in a timely fashion), but could not order the OFDC due to "low availability." Huge bummer!





## Tlikikila River

Do you know anything about the Tlikakila River? I must admit, that when this stamp was issued by the USPS in 2019, I had never heard of this river. I did not know where it originated, ended, how long it is, what state it is located in, or even how to pronounce it. So, a look into Wikipedia says this:

The Tlikakila River (in the Dena'ina Athabascan "tiq'a Qilanhtnu", literally "salmon-are-there river") is a stream 51 miles (82 km) long in the U.S. state of Alaska. The river, lying entirely within Lake Clark National Park, flows southwest from Summit Lake in the Chigmit Mountains of the Aleutian Range to Lake Clark.

The Tlikakila is one of three national "wild rivers" in Lake Clark National Park. The other two are the Mulchatna and the Chilikadrotna, all added in 1980 to the National Wild and Scenic Rivers System.



Was that helpful? Somewhat, but as is often the case, a whole bunch of other questions resulted, such as:

- 1. Who speaks the Dena'ina Athabascan language and what letters does it use?
- 2. Where is Lake Clark National Park, and when did this become a National Park?
- 3. What and where are the Chigmit Mountains?
- 4. What is the Aleutian Range?
- 5. What and where are the Mulchatna and Chilikadrotna Rivers?
- 6. Finally, how are all these unusual names pronounced?

Dena'ina is one of the Dene (Na-Dene) languages. The Kenia, who often now refer to themselves as Kenaitze, use



a dialect that is one of five Dena'ina dialects and is spoken by the Kahtnuht'ana, or "People of the Kenai River" who occupy the eastern heartland of the Outer Inlet. The Dena'ina language has 41 letters or letter combinations, including letters that have a "hat". Here is a list of the Dena'ina letters:

### ' a b ch ch' d dl dz e f g gg gh h ĥ i j k' l ł m n q' r s sh t' tl' ts' u v w x y ŷ z zh

The alphabet also has a letter known as the "barrel L" which is the letter L with a line drawn through it. There are fewer than 100 living people (some say about 50 people) who use this language as their first language, making it an endangered indigenous language. The policy of the Alaska Territorial Schools (Alaska was a U.S. Territory from 1912 to 1959) to extinguish the indigenous languages is one of the main reasons the Dena'ina language is very rarely spoken.

As an interesting aside, Alaska was purchased from Russia on April 9, 1867 for \$7 million, which was a very large sum at the time. The U.S. Secretary of State who negotiated the purchase was William H. Seward, and for many years the purchase was derogatorily called "Seward's Folly." Alaska was originally called the "Department of Alaska" (1868 to 1884), then the "Division of Alaska" (1864 to 1912) and then became "Territory of Alaska" until it became the 49th state of the United States on January 3, 1959. It remained the newest state for just 7 months when on August 21, 1959, Hawaii became the 50th state.

The Aleutian Range is a major mountain range located in southwest Alaska. It extends from Chakachamna Lake (80 miles/130km southwest of Anchorage) to Unimak Island, which is at the tip of the Alaskan Peninsula. It includes all of the mountains of the Peninsula. The Aleutian Range is special because of its large number of active volcanoes, which are also part of the larger

Aleutian Arc. The mainland part of the range is about 600 miles (1000km) long. The Aleutian Islands are (geographically) a partially submerged western extension of the range that stretches for another 1,000 miles (1,600km). However the official designation "Aleutian Range" includes only the mainland peaks and the peaks on Unimak Island. The range is almost entirely roadless wilderness. Katmai National Park and Preserve, a large national park within the range, must be reached by boat or plane.

Lake Clark National Park became a national park in Alaska in 1982. Because the park is not on the road system, it is primarily accessed by small airplane. The park reminds all visitors that small air travel in Alaska involves the passenger in a greater capacity than normally on commercial flights. Here is what the park says:

Lake Clark is rugged and remote. Planning ahead for flexibility and inclement weather is vital to a successful trip. Give yourself a few extra days on each side of your travel in the likely event of weather delays. In Alaska, we talk about the "circle of safety"



where the passenger is a partner in ensuring a safe flight. Passengers should take an active role to ensure

everyone's safety by getting familiar with the details

of their trip. As a passenger, you should be willing to

ask questions in a polite way if you feel uncomfortable

about something or have additional questions. This

idea can be intimidating, but if you are uncomfortable





# An 1877 Swiss Postal Card to the Isle of Mull, Scotland

This uprated Swiss postal card originated in Interlaken 1 September 1877 and was sent to Miss H.M. Chamberlain, c/o Mrs. Guthrie, Duart, Isle of Mull, N(orth) B(ritain), England (Figure 1). Trying to research the names on this card would be a serious challenge without using the diverse and divergent references available on the internet. Maiden names and married names often make it impossible to identify individuals, but this address was unique. The fact that Duart turned out to be a castle on an isolated headland overlooking the Sound of Mull whetted my interest; its history leading me to the Guthries.

Mrs. Anne Beresford Guthrie (b.1815) and her unmarried sister Harriet Mary Chamberlain (b.1816) were both born in Rio de Janeiro to Sir Henry Chamberlain, Consul General and charge d'Affaires to Brazil. The family returned to England and Chamberlain died in 1829. Anne married Mr. Arbuthnot Charles Guthrie in 1860; Harriet remained unmarried, and it is probable she frequently visited Duart.




Fig. 2. Reverse of the card.

The "H.S.C." (Figure 2), who sent the card to Miss Chamberlain, was Houston Stewart Chamberlain, a nephew studying in France and Switzerland, where he came under the influence of a Prussian tutor. Chamberlain later wrote many political philosophy books which became a reference for the German anti-semitism movement in the early 20<sup>th</sup> century. He married the granddaughter of Franz Liszt, who was also the step-daughter of the composer Richard Wagner.

In 1367, a Maclean married a MacDonald, and the combined family lands formed a single estate on which Duart Castle was built. Alterations were made during the

16<sup>th</sup> and 17<sup>th</sup> centuries, but it deteriorated to ruins by the early 19<sup>th</sup> century. At some point in the 18<sup>th</sup> century, the ancestral household moved to a newly built Georgian home at Torosay, two and a half miles away on the same estate.

Torosay Castle was demolished in 1858 and rebuilt as a country home by owner John Campbell. The grander, new residence was named Duart House (Figure 3). Financial losses suffered during the American Civil War forced Campbell to sell the property in 1865, allowing Mr. Guthrie and his wife, Anne, to purchase the estate. It was their home until Guthrie died in 1897. Later, Duart House was to be renamed Torosay Castle.

Unfortunately for Anne Guthrie, the law did not allow a wife to inherit her husband's real estate holdings, forcing ownership of her home to go to the next legitimate male heir. As no children had issued from the marriage of the Guthries, the estate went to a distant nephew. It is reported that Anne stripped the house of all art, furnishings and household items, taking them to London where she established a new residence. The new owner discovered a

completely bare house when he came to inspect his inheritance!

Interestingly enough, this is not the end of the Duart story. The punch line came 111 years later in 2008 when the current owner, Chris James, the fifth laird of Torosay Castle (Figure 4), was preparing the property for sale. During the cleanup, he hired a locksmith to make a key to open a locked cabinet which was part of a huge built-in dining room sideboard. Inside he found a "treasure of alcoholic delights." The supreme find was a bottle of 1893 Veuve Clicquot champagne in perfect condition. The darkness of the cabinet had preserved both the paper label and the appearance of the contents. This bottle was returned to the vineyard and is now on display in Reims, France. Since there is only one remaining bottle of this vintage, it is the most exclusive champagne in the world and considered priceless!

Unusual postal history destinations can lead to remarkable stories. Look at some of your cards and covers, use the internet, especially Google Maps, and see what *you* discover.

On December 29th, 2024, I rode the MV Coho on the 65th anniversary of its inaugural run from Port Angeles, Washington, to Victoria, British Columbia, Canada.

I presented an original cover and insert to the purser Nathan and that earned me an invite to meet Captain Ben on the Bridge.

A great experience I shall never forget.







FACTS ON THE NEW MOTOR VESSEL "C O H O" OWNED BY BLACK BALL TRANSPORT, INC.

built by The 341-foot-long COHO was designed by Philip P. Spaulding and Associates and the Ship was launched on May 25 and she was turned over to her owners on December 23, 1959.

The total cost is over three million dollars.

She has a cruising speed of 16 knots and is driven by two 8-foot propellers. Her two main engines are Cooper-Bessemer direct-reversing diesels with a combined rating of 4,160

The COHO's gross tonnage is 5,360. Her fuel tanks can hold 70,900 gallons of gallons of field, 11,600 gallons of diesel and 3,000 gallons of clean lube oil as well as 23,200 over 7,000 miles.

The car deck has a vertical overhead clearance of 1h16" and has space to accommodate 76 standard 2h-foot freight trailers or 108 logg-wheelbase automobiles. Passengers have two spacious lounges with low windows for full visibility, and the restaurant will be opened at an early date this spring.

The ship will carry a crew of around twenty men who will have their own dining rooms, recreation rooms and sleeping quarters on the upper deck. Due to rotation of the crew there will be a total of some forty full-time employees on the ship's payroll.

The ship is designed for roll-on and roll-off freight operations between Seattle, Port Townsend, Port Angeles and Victoria with service provided to and from beyond and inland points by truck. Passenger service will be provided only between Victoria and Port Angeles. No passengers will be carried to, from or between any other points.

Her spring and winter passenger schedule between Port Angeles and Victoria is as follows with two round trips daily:

Leave Port Angeles --- 7:00 a.m. and ll a.m. Leave Victoria----9:00 a.m. and 1 p.m.

Effective January 13, Greyhound buses will leave Seattle at 7:45 a.m. to connect with the COHO at Port Angeles for Victoria. Passengers from Victoria may leave there at 9 a.m. via COHO and connect with the bus for Seattle at 12:45 p.m. arriving in Seattle at 4:15.

There will be additional crossings daily between Port Angeles and Victoria during the summer months with schedules to be announced this spring. Fare for the crossing will be \$2.00 per person and \$6.00 per car on a one-way basis. Special group rates are available on request.

In 1959, the price of vehicle and 2 passengers was \$10 and now 65 years later it is \$99, almost a 10-fold increase. By reference, US postage was  $4\phi$  and it is now  $73\phi$ , an 18fold increase.

- b) All competitive exhibits must be the bona fide property of the exhibitor.

### B. Exhibit Classes:

- a) GENERAL CLASS is open to any competitive exhibit except those eligible for either the youth or one-frame class.
- b) ONE FRAME CLASS
- c) YOUTH CLASS is open to exhibitors who will be age 21 or younger on January 1, 2024. Entry applications for this class must include a statement, endorsed by an adult, that the entry is the property of, and was prepared by, the entrant. Youth exhibitors: please also see the Youth section of the PIPEX website.
- d) NON-COMPETITIVE CLASS

Exhibits in any of the classes above may be in any of a variety of subclasses, viz. Advertising, Patriotic and Event Cover; Aerophilately; Astrophilately; Cinderella; Display; Experimental; First Day Cover; Maximaphily; Picture Postcard; Postal History; Postal Stationery; Revenue; Thematic; Topical; Traditional.

### C. Entry:

- a) An individual exhibitor may submit up to two multi-frame exhibits and up to two single-frame exhibits.
- b) All exhibits must be entered by Class on the official entry form provided by the PIPEX Exhibit Committee. The correct fees must accompany the entry form.
- c) Single-frame exhibits will be accepted in priority sequence:
  - 1) One exhibit each by members of convening societies, youth (up to six youth exhibits), and first-time exhibitors in any WSP show.
  - 2) One exhibit each by residents of the area served by the Northwest Federation of Stamp Clubs
  - 3) One exhibit each by any other exhibitors
  - 4) Second exhibit by exhibitors, following the same priorities as in categories (1) to (3) above
  - 5) Entries will be accepted up to March 18, 2025, or until all available space has been filled if that event should occur earlier.
- d) Receipt of entries will be promptly acknowledged. A defined number of frames are reserved for the convening organizations until February 18, 2025.
- e) Signing the official entry form denotes acceptance by the exhibitor of all requirements set out in this prospectus.

f) Each exhibit entry must include (1) the Entry Form, (2) the title page, (3) a one- or two-page synopsis, and (4) the required fee. Mail payment to Norma Nielson, 1561 Braeman Village, Eugene, OR 97405. Title pages and synopses may also be mailed to the same address, but the PIPEX Committee *prefers* to receive them by email to <a href="maileon@ucalgary.ca">nnielson@ucalgary.ca</a>, in Word, PDF, or rtf format attachments to an email message. Entry forms may be either mailed or emailed.

**Entries submitted without the title page and synopsis will not be accepted.** Revised title pages and/or synopses may be forwarded by March 18, 2025, to the mail or email address just given.

### D. Frames and Pages:

- a) Exhibits will be displayed in frames that hold 16 pages, maximum 8.5 inches by 11 inches or A4 in size, in 4 horizontal rows of 4 pages each. Wider pages are acceptable if they fit in a row of a frame.
- b) Pages must be numbered consecutively on the back, bear the exhibitor's name on the back (not the front), and be enclosed in transparent sheet protectors.
- c) Each GENERAL CLASS exhibit is limited to a maximum of ten (10) frames. Each YOUTH CLASS exhibit is one frame, except that experienced youth exhibitors may apply for up to five frames.

### E. Exhibit Fees:

- a) The entry fee for adult exhibits is \$50.00; in addition, the frame fee is \$10.00 per frame. Thus, single frame exhibits must pay fees of \$60 each, a four-frame exhibit \$90, and a ten-frame exhibit \$150. The fee includes mounting a virtual copy on the PIPEX website if provided by the exhibitor.
- b) Youth Class \$5.00 per frame

Note: If the exhibit is to be returned to the exhibitor by the PIPEX Exhibit Committee after the show, the full amount of return postage plus insurance must be remitted with the entry application. Excess amounts over \$1.00 will be refunded.

### F. Delivery:

- a) Exhibitors can deliver their exhibits in person or via an agent. Otherwise, exhibits should be sent via USPS mail or express carrier such as FEDEX. Other material should not be enclosed in the same package as the exhibit.
- b) Mailed exhibits must be shipped prepaid to be received by the PIPEX Exhibit Committee no later than April 29, 2025. d) An exhibitor who indicates on the exhibit entry form an intent to send the exhibit *also* virtually, s/he will be sent instructions for electronic delivery.

### G. Exhibition Hours/Exhibit Return:

- a) The exhibition will open at 10:00 a.m. on May 2 and will close at 4:00 p.m. on May 4.
- b) Exhibitors or their agents, on providing proof of identity, may obtain their exhibit from the PIPEX Exhibit Committee immediately after the close of the exhibition.
- c) No exhibit or part thereof may be mounted, dismounted, or removed during official show hours. Those with tight airline schedules will be allowed access to takedown at 3:30 p.m. Otherwise please do not exhibit if you will need to take your exhibit down before 4:00 p.m. on May 4, 2025.

### H. Insurance:

- a) Exhibit owners must provide their own insurance.
- b) All reasonable precautions will be taken for safeguarding the exhibits while they are in the possession of the PIPEX Committee. The exhibit area and bourse will have 24-hour security guards.

c) The exhibitor agrees that no responsibility of any kind or character will attach to the Northwest Federation of Stamp Clubs nor to any officers or members of the same, nor to the PIPEX Committee or to any of its members, nor to the Portland Philatelic Exhibitions, nor to Monarch Hotel or its employees, for any loss or damage to any exhibit or material submitted in competition or non-competition, from any cause whatsoever.

### I. Judging:

- a) A panel of APS accredited judges will make decisions by deliberation and consultation among themselves; their decisions will be final. Judges will receive the exhibit title and synopsis pages to assist in their preparation; some materials may be made available on the PIPEX website unless the exhibitor indicates on the Entry Form that s/he wishes to opt out.
- b) Judging will be in accordance with the *APS Manual of Philatelic Judging and Exhibiting, Seventh Edition (October 2019)*. It is strongly recommended that exhibitors study this latest edition, available on the APS web site (https://stamps.org/Portals/0/Judging-Manual 1.pdf).

### J. Awards:

- a) For the GENERAL CLASS the PIPEX Exhibit Committee will place at the disposition of the judges, PIPEX large gold, gold, large vermeil, vermeil, large silver, silver-bronze and bronze medals plus ribbons, certificates of award, certificates of appreciation and other awards, including the Grand and Reserve Grand award.
- b) For the SINGLE FRAME CLASS, judging will be based on the same eight levels of awards, with a Grand award for the best single frame exhibit.
- c) All awards will be granted in accordance with merits of the exhibit.
- d) The winner of the multi-frame PIPEX Grand Award will be eligible for, and is expected to enter, the APS Champion of Champions competition at the APS Great American Stamp Show, August 14-17, 2025, in Schaumburg, IL. The winner of the single-frame grand award will be eligible for, and expected to enter, the corresponding Single Frame Champion of Champions competition at Chicagopex to be held November 21-23, 2025.

### K. Ruling Authority:

Any and all questions that may arise concerning the exhibition which are not provided for by the requirements of this prospectus will be decided by the PIPEX Host Committee in its sole and absolute discretion.





## **Nominations are Open**

for the three Federation awards which, when awarded, are given at PIPEX.

- Each member organization can nominate yearly one, maybe more, member for the Club Member Service award. This award may be received by an individual only once. All nominees will be announced at the PIPEX meeting and a certificate prepared for them.
- 2) Each member organization can nominate one individual for the **Meritorious Achievement** Award. The award can be won only once. The winner(s) will be recognized at the PIPEX banquet.
- 3) Each member organization can nominate one individual for the **Northwest Distinguished Philatelist** Award. The award can be won only once. The winner(s) will be recognized at the PIPEX banquet.

### **Nominations**

Nominations can be made by any member organization or by a Board member and should be submitted in a letter directed to the Executive Secretary [larry.crain@gmail.com or PO Box 4395, Medford, OR 97501]. In the nominating letter, include the nominee's achievements and qualifications in less than 350 words or 35-50 for the Club Member Service award. These nominations should be received by April 1 (technically the by-laws say earlier but this was before electronic communication).

Any resident of the Northwest Federation area is eligible for the Meritorious Achievement Award and the Northwest Distinguished Philatelist Award. The Distinguished Philatelist nominee need not be a member of a Federation organization.

The Executive Secretary will gather all nominations and forward them to the Board members for a **yah** or **nay** vote. A 2/3 vote is needed to receive the award. There is no

requirement of the number awarded yearly. The Club Member Service Award does not need a vote of the Board.

### **Criteria**

The achievement criteria for the Member Service Award shall be the rendering outstanding and distinguished local service by:

- 1) Having promoted and furthered the goals of philately in general.
- 2) Having provided distinguished service, primarily to a member organization or group of member organizations. This award will be based on a combination of length of leadership, quality of leadership, and achievements.

The achievement criteria for the Northwest Distinguished Philatelist Award shall be having rendered outstanding and distinguished service to philately in general in one or more of the following areas:

- 1) Published research and study in some aspect of philately.
- 2) Assembling a world-class collection.
- 3) Significant furthering of philately on a national scale.

The achievement criteria for the Federation Meritorious Achievement Award shall be:

- 1) Having rendered outstanding and distinguished service directly to the Northwest Federation of Stamp Clubs and its member organizations.
- 2) Having promoted and furthered the goals of the Federation as stated in the Constitution.
- 3) Having provided direct, significant contributions to the Federation as an organization in administration, leadership, and support.
